

House rules HSV Philips

(These house rules have been translated into different languages using Google Translate.)



What is allowed and what is not allowed:

1. ACCESS and FISHING RIGHTS are exclusively:

Members of the HSV Philips who are in possession of a valid membership card with a recent photograph and signature. Different licenses are your standard membership card with or without pass Sportvisserij Netherlands, night fishing license or a day license.

The Kempense Plassen may only be accessed via the main entrance.

2. OPENING

The Kempense Plassen are open all year. Stay on the lakes is permitted daily from one hour before sunrise until two hours after sunset, except the members who are in possession of a night fishing license. If necessary, the Kempense Plassen are closed by the board.

3. PARKING

Bicycles, mopeds may be parked at the fishing grounds along the waterfront if they are used for the carriage of fishing equipment. Approach Roads and bridges release.

On the main road a speed limit of 20 km / h.

4. FISHING RIGHTS

In the period from 1 January / 31 December may be fished by up to TWO rods. However if one is fishing with lures, GREATER THAN 2.5 CM, it may only be fished with a rod. For restrictions see especially art. 7.

5. FISHERIES

The provisions mentioned in this membership card on the Kempense Plassen of force in accordance with the provisions set out in the Fisheries Act. (See list of fishing waters or www.sportvisserij nederland.nl)

6. CONTROL

At the request of auditors, directors and / or officers in charge of supervising the Fisheries Act, the documents are handed over prescribed and should be given permission to inspect the fish shafts must, fish boxes, etc. If found violations, these people right this membership card to take and give to the Board or to the appropriate annotated place.

7. IT IS NOT ALLOWED

- a. Therefore, disturbing the peace through music or noise, and alcohol abuse in any form;
- b. itself to move in or on the water, other than in an emergency;
- c. cycling, riding a moped or scooter off the paved road and adjacent parking (mopeds and motorized bicycles should switch the engine off the main trail);
- d. damaging the piling and planting;
- e. to fish bridges; with floating baits and bob, fly fishing is allowed;
- f. dirt, debris, and the like to lie along the waterfront or throw in the water, so dispose themselves;
- g. be located with a dog (s) on the property;
- h. to fish in the Run from the weir to the Dommel;
- i. Fishing in the period from 1 April to the last Saturday in May with meat products, lures a dead fish or a piece of fish; Exceptions are aerobatics with a size of up to 2.5 centimeters.
- j. 1 March to the last Saturday in May closed to fishing for pike. perch, zander.
From 1 April to the last Saturday in May.
Barbel, chub and ide from 1 April to 31 May.
- k. to fish with live bait;
- l. fishing and feed with colored maggots;
- m. To have a catapult available or possession;
- n. trailers for vehicles bring to the fishing grounds;
- o. block the aisles, also along the waterfront;
- p. camping and place tents (. umbrellas, or single vison derk omens with a maximum wingspan of 3 meters are allowed in the colors green or camouflage provided that they appear on the published list);
- q. use a keep net and / or storage container outside the organized competitions;
- r. organize without written permission of the club competitions;
- s. to use FIRE or BARBECUE on our property, be taken with offense your license will and will decide the government on measures to be taken.

8. TREATMENT OF FISH

- a. All fish must be put back immediately;
- b. ALL ANGLERS are at all times required the fish to land in a landing net or an unhooking mat.
- c. CARP FISHERMEN are at all times required an unhooking mat, anti-septic, landing net (minimum 1 meter diameter) and have a bucket of pond water at hand;

9. WASTE

People are required to bring their homemade waste themselves and not to fall into the bins. The bins along the pond can be used for small packings which visitors may otherwise be lost. All this to prevent pests and increasing waterfowl caught up in the waste.

10. VIOLATIONS

Violations of the provisions set out in this membership card, can be punished;

11. LIABILITY

The association accepts no liability for damages to persons and / or property resulting from an accident, injury, theft, and the like during and due to stay on the waters to which this evidence provides direct or indirect access.

12. WORK

The board may, if necessary receivers for work close to the ponds full or in part for overfishing and entry. Should take into account that there may be some discomfort during the entire year due to maintenance.

13. NIGHT FISHING IS PROHIBITED, except that the fisher is in possession of a special night out fishing license data by HSV Philips.

14. DOMMEL / RUN

For fishing in the Dommel and Run as far as adjacent to the area of the Kempense Plassen, the provisions in force listed on the membership card.
